

**AUDI x 27 – 28 SEPTEMBER 2025 CAR EXPO PROMOTION ("PROMOTION")**  
**(as of 16 September 2025)**

**Terms And Conditions**

These terms & conditions ("**Terms**") apply as between you and Audi Singapore Pte Ltd ("**Audi**") in connection with the Promotion.

The images used in publicity for the Promotion are for illustrative purposes only.

**1. Eligibility**

- 1.1. To participate in the Promotion, you must make a Valid Purchase.
- 1.2. To make a Valid Purchase, you must:
- (a) Purchase existing stock of an Audi vehicle between 17 September 2025 to 7 October 2025 (both dates included) ("**Promotion Period**");
  - (b) Submit the Vehicle Sales Agreement during the Promotion Period; and
  - (c) Register and fully pay for the vehicle by 30 November 2025.

Note: Order of any vehicles which are not immediately available is not counted as a Valid Purchase

- 1.3. Repeated tries at the Audi Plinko Board are not allowed. If you make repeated tries, Audi reserves the right to disqualify you from the Promotion.
- 1.4. Only natural persons are eligible to participate in the Promotion. Corporate or other entities are not eligible to participate in the Promotion.
- 1.5. Employees and members of management of the following entities and/or the following persons shall not be entitled to participate in the Promotion:
- (a) Audi Singapore Pte Ltd; or
  - (b) Any person involved in organizing, promoting and/or conducting the Promotion.
- 1.6. Immediate family members (i.e. grandfather, grandmother, father, mother, brother, sister, son and/or daughter) of any person referred to in Clause 1.5 above shall not be entitled to participate in the Promotion.
- 1.7. Notwithstanding the aforesaid, Audi reserves the sole and absolute discretion to determine the eligibility of any person in relation to the Promotion at any time.

**2. Participation in the Promotion**

- 2.1. By participating in the Promotion, you:
- (a) agree to be bound by these Terms and any amendments thereof; and
  - (b) agree to be bound by the decisions of Audi, which are final and binding in all matters relating to the Promotion and the Voucher.

- 2.2. Failure to comply with these Terms shall result in an automatic disqualification from the Promotion and/or where applicable, the immediate forfeiture of the Voucher.
- 2.3. Audi Singapore Pte Ltd reserves the rights at its sole discretion, at any time without notice and without assigning any reason, to amend the Terms, withdraw the Promotion and/or substitute the Voucher.

### 3. Plinko Board Game Mechanics

- 3.1. Upon purchasing an Audi vehicle during the Promotion Period, you will be entitled to drop one ball into the Audi Plinko Board either at the Audi House of Progress or at the Car Expo, according to the following table:

- 3.2. Your right to play the Audi Plinko Board game shall be forfeited if you do not play the Audi Plinko Board game during the Promotion Period.
- 3.3. The Audi Plinko Board contains slots which are named various destinations. The ball will land randomly into a slot that corresponds to a destination. When the ball lands onto the slot, you are regarded to have won a voucher of a value determined according to Clause 4.2 below and the destination named in that slot. You will be notified of the value of the voucher.
- 3.4. The value of the voucher will be noted on your vehicle sales agreement for Audi's records.

- 3.5. We assume that you will comply with the requirements to make a Valid Purchase under Clause 1.2, even if you (or your authorised representative) play the Audi Plinko Board game before you meet all the requirements in Clause 1.2. If you have played the Audi Plinko Board game but you do not meet the requirements in Clause 1.2 above by 30 November 2025, you are not eligible to participate in the Promotion. Any voucher will be forfeited in such a case.

#### 4. **Vouchers**

- 4.1. The vouchers are from Chan Brothers Travel Pte Ltd ("**Chan Brothers**") and are based on the expected price of a pair of round-trip air tickets from Chan Brothers for travel with Singapore Airlines in economy class to the destination named on the Plinko Board.
- 4.2. The value of the voucher depends on the destination. The following table includes information regarding the value of the Voucher against the destination:

#### 5. **Claiming the Voucher & Voucher Redemption**

##### Claiming the Voucher

- 5.1. The voucher will be presented to you upon the delivery of the vehicle to you.
- 5.2. You are required to produce your identity card and any other documents or information as may be requested by Audi in order to claim the voucher. If you fail to provide any of the required documents or information, Audi shall not be obliged to deliver the voucher to you. Audi shall thereafter not be liable in respect of the voucher.

### Voucher Redemption

- 5.3. Eligible customer will have to contact Chan Brothers directly to redeem the travel vouchers. Terms and conditions of the travel vouchers apply.
- 5.4. In addition to Chan Brothers' Terms & Conditions, the voucher is subject to the following terms and conditions:
- (a) The voucher must be redeemed within 2 years from the date of issue. Note: Please check the date of issue of the voucher at the time the voucher is presented to you. The vouchers will be purchased and issued earlier than the date the voucher is presented to you. In the event of failure to redeem the voucher for any reason whatsoever within the validity period, the voucher will be forfeited without any compensation.
  - (b) The voucher is not exchangeable or refundable for cash in part or whole.
  - (c) If the price of the ticket upon redemption exceeds the value of the voucher, you will need to top-up the difference to purchase the ticket.
  - (d) You may choose to top up for specific flight dates and/or upgrade your flight class.
  - (e) The use of the Vouchers is subject to black-out dates.
  - (f) The voucher is in Singapore currency and valid only in Singapore. The voucher can be used at all Chan Brothers promotional events (including Chan Brothers Travel Fairs) and at Chan Brothers retail stores.
  - (g) The voucher is not valid unless duly stamped.
  - (h) The voucher is not valid for more than one use.
  - (i) The voucher is not exchangeable for other denominations.
  - (j) The voucher is not valid if defaced or tampered with.
  - (k) The voucher is not replaceable if lost or stolen.
  - (l) The voucher is valid for one time use only. Multiple vouchers can be used for single redemption.
- 5.5. The voucher is redeemable for all products and services including tour packages, air tickets, cruise packages, hotel accommodations, and other services available at retail stores of Chan Brothers Travel Pte Ltd. ### **6. Others**

- 6.1. If the consumption of the voucher incurs any additional costs or tax liability, such additional costs or tax is your sole responsibility.
- 6.2. The consumption of the voucher shall be subject to these Terms and such further terms and conditions which Chan Brothers, Audi and/or either party's Affiliates (as defined at Clause 6.13 below) may notify to you.
- 6.3. Audi shall retain complete discretion in deciding on all matters relating to the Promotion and all of Audi's decisions shall be final and binding on you. Audi shall not be obliged to enter into any discussion with you regarding Audi's decisions.

- 6.4. You hereby expressly and irrevocably consents to, and grant to Audi and its Affiliates the right to use the survey information submitted by you in any manner as Audi shall see fit.
- 6.5. By participating in the Promotion, you acknowledge that Audi and its Affiliates shall, in accordance with applicable data protection laws, have the right to, and you consent to Audi and its Affiliates to collect and store the personal data/information submitted by you for the purposes of:
- (a) entry into the Promotion;
  - (b) coordination with Chan Brothers;
  - (c) to contact and/or mail you (whether electronically or otherwise) at any time with information and/or mailers containing customer service, business, marketing, advertising and/or promotional information of any kind, whether or not related to Audi's programmes, contests, promotions and/or activities, and Audi shall additionally have the right to provide goods and/or services whether by Audi directly or by Audi's Affiliates, designated representatives and/or business partners to you;
  - (d) to conduct market research and analysis, including surveys and polls, and
  - (e) to send you information, promotions and updates including marketing and advertising materials in relation to Audi and its Affiliates' goods and services and those of third party organizations selected by Audi.
- 6.6. By participating in the Promotion, you agree to take part in any and all marketing, promotional, publicity exercise as may be conducted by Audi and/or its Affiliates arising or with respect to the Promotion and you irrevocably and unconditionally grant to Audi and its Affiliates all consents and waivers necessary for Audi and its Affiliates to record and use your performance, appearance, likeness and/or particulars as the case may be, in any manner whatsoever and in any part of the world as Audi and its Affiliates shall in their sole discretion deem fit. You acknowledge that Audi and its Affiliates shall be at liberty to publish and otherwise use any recordings made by Audi and/or its Affiliates, including without limitation the information on the Promotion, telephone call, telephone recordings, audio recordings, visual recordings and photographs, for the promotion and publicity of the Promotion. You hereby expressly waive any and all rights which you may acquire or have under the provisions of the Copyright Act 2021 of the Republic of Singapore including any subsidiary legislation (and any subsequent enactment or amendments thereto) and any other moral rights which you may have or be entitled under any such legislation now existing or in the future enacted in any part of the world.
- 6.7. You irrevocably release Audi and its Affiliates from and against any and all claims, suits, liabilities, or damages which you may have in connection with your particulars or personal data/information which you provided to Audi and/or Audi's Affiliates, which particulars or personal information has been and/or is being (i) used by Audi and/or its Affiliates (or any third party which Audi has released the particulars/information to) in any manner or format; and/or (ii) disclosed or

otherwise provided by Audi and/or its Affiliates to any third party, for the purposes provided herein (including that as set out in Clause 6.6 above).

- 6.8. Notwithstanding anything contained herein, Audi reserves the right at any time, in its absolute discretion to partially or completely postpone the Promotion or to amend, and/or add and/or delete any of these terms and conditions with prior notification to you, and you shall be bound to such amendments, additions or deletions when effected.
- 6.9. Audi and its Affiliates shall not be liable in any way to you or any person for:
- (a) any loss, damage or expenses incurred by the you arising in connection with the Promotion or the voucher;
  - (b) any act or omission relating to any person's participation in the Promotion however caused;
  - (c) late or non-notification of any information in relation to the Promotion or voucher;
  - (d) incomplete, lost, late, damaged, illegible or misdirected notices;
  - (e) mail, e-mail, technical, hardware or software breakdown of any kind; or
  - (f) lost or unavailable network connections or failed, incomplete garbled or delayed electronic transmission or transactions, which may limit your ability to participate in the Promotion or claim the voucher or redeeming the value of the voucher.
- 6.10. You shall indemnify and keep Audi and its Affiliates and their respective officers, agents and employees ("**Indemnified Parties**") fully indemnified against any and all loss, damage, claims and costs (including legal costs on a full indemnity basis) suffered and/or incurred by any of the Indemnified Parties as a result of your breach of any of these terms and conditions.
- 6.11. In the event of any inconsistency between these terms and conditions and any brochure, marketing or material relating to the Promotion, the terms and conditions contained herein shall prevail.
- 6.12. Any person who has not made a Valid Purchase may not enforce any of these terms and conditions under the Contracts (Right of Third Parties) Act 2001.
- 6.13. For the purposes of these Terms, "**Affiliate**" of Audi shall mean any corporation, company, partnership or other entity (whether in Singapore or elsewhere) which is controlled by Audi; controls Audi; or is under common control with Audi. For this purpose, "**control**" means the authority or ability, whether exercised or not, to control an entity's business and affairs, which authority shall conclusively be presumed to exist when more than fifty per cent (50%) of the controlled entity's outstanding shares or ownership interest representing the right to make decisions for such entity are owned or controlled, directly or indirectly, by the controlling entity, and/or the controlling entity possesses, directly or indirectly, the power to influence the decision-making process, the direction of management, and the policies of the controlled entity.

6.14. The terms and conditions of this Promotion shall be governed by and construed in accordance with the laws of the Republic of Singapore. You hereby submit to the non-exclusive jurisdiction of the Courts of the Republic of Singapore.
