Release of Liability and Indemnity Form

All persons attending the Audi driving experience who wish to participate in the racetrack events must complete this form and return it to Audi event staff before they will be permitted to participate.

Acknowledgement of Participation, Release and Indemnity

1. I will be attending the Audi driving experience and will be participating in the various motor vehicle racetrack events to be held (Event).
2. I hereby acknowledge that I am fully aware of and accept any and all risks that may be involved in or may arise from my participation in the Event and to the maximum extent permitted by law: (a) release and forever discharge Volkswagen Group Australia Pty Limited trading as Audi Australia ("AA"), its directors, officers, servants and agents or any of them (Relevant Persons); and (b) indemnify and hold all Relevant Persons harmless, from all damages, losses, expenses, claims, demands, actions, and other liabilities suffered or incurred by me (howsoever occurring) arising out of or in connection with the Event and my participation in it.
3. I warrant to AA that I: (a) hold a full and valid driver's licence for driving in the state or territory the event is held (not a probationary or learner licence) and that I will as at the date of my participation in the Event be over the age of 18 years; (b) am not suffering any medical conditions or other conditions which would adversely impact on my participation in the Event or which could be aggravated as a result of my participation in the Event; (c) will not be under the influence of any alcohol, illegal drugs or substances (or other drugs that may impact on my ability to drive a vehicle) during the time I will be participating in the Event and may be subject to an alcohol breath test; (d) will not consume alcohol, illegal drugs (or other drugs that may impact on my ability to drive a vehicle) in the 12 hour period immediately prior to participating in the Event.
4. I acknowledge and agree that in the event that AA discovers or suspects (within the reasonable opinion of any AA representative supervising the Event) at any time that: (a) any of the above warranties is untrue or inaccurate in any way, AA may prevent me from taking part in the Event or may discontinue my participation in the Event; or (b) I am in the possession of, or may have used any, illegal drugs or substances, AA will immediately notify the police, hand over any illegal drugs or substances found in my possession to the police and I may be tested for use of illegal drugs or substances by the police.
5. I indemnify and hold all Relevant Persons harmless against: (a) all claims, demands, actions or proceedings that may be brought against a Relevant Person in respect of the death or bodily injury to any third parties and all loss, damage or destruction to property caused by or arising directly or indirectly from my participation in the Event; and (b) any damages, losses, expenses, infringements, claims, demands, actions, and other liabilities suffered or incurred by a Relevant Person arising from or in connection with any of the above warranties being untrue or inaccurate in any way.
6. I agree to immediately inform AA of any damage or injury to persons or property caused or connected to my participation in the Event and to provide all necessary assistance to AA in respect thereof, including by completing such claim forms, executing such documents and testifying in such suits and actions in connection with such matters as may be requested by AA.
7. I declare that I have read and understood this Release and Indemnity and agree that its terms are reasonable and that I am subject to the provisions contained in this Release and Indemnity.
